By-law #04-131

A By-Law to provide for indemnities to be paid to the Mayor and Councillors.

WHEREAS Section 173 of the *Municipal Act*, being Chapter 154 of the Revised Statutes of the Yukon, 2002 provides for indemnities and remuneration for attending meetings to be paid to the Mayor and Councillors of a municipality;

NOW THEREFORE the Council of the municipality of the Village of Teslin, in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. This By-Law may be cited as the Council Indemnity By-Law.
2. The annual indemnity for the Mayor shall be a maximum of seven thousand two hundred dollars (\$7,250) apportioned as follows: three thousand seven hundred fifty (\$3,750.00) as a base indemnity and an additional one hundred twenty five dollars (\$125.00) per regular or special meeting of Council attended.
3. The annual indemnity for each Councillor shall be a maximum of sixty five hundred dollars (\$6,500.00) apportioned as follows: three thousand dollars (\$3,000.00) as a base indemnity and an additional one hundred twenty five dollars (\$125.00) per regular or special meeting of Council attended.
4. The annual indemnities shall be paid monthly or as otherwise determined by resolution of Council. Where a member of Council fails to serve in their respective office for a full twelve months, as determined by resolution of council, his or her base indemnity shall be prorated on a monthly basis for the period served.
5. One-third of the total annual indemnity shall be paid as an allowance for expenses necessarily incurred by the Mayor or Councillor in the discharge of the duties of their office.
6. In addition to the indemnity referred to in section 2 and 3, Council may, by resolution, approve the payment to members of Council, the sum of \$200.00 per day or \$150.00 per half-day while attending meetings or performing other duties on behalf of the municipality in the capacity of Mayor or Councillor outside of regular or special meetings of Council
7. In addition to the allowance referred to in Section 6, Council may, by resolution, approve the payment of reasonable allowances, pursuant to Appendix "A", for traveling, for meals and accommodation, and for out-of-pocket expenses necessarily

incurred in attending meetings of the Council or its Committees, or for performing other duties as Mayor or Councillor.

8. Mayor and Councillors, when duly appointed as members of its Committees, shall receive an honorarium, as established for each Committee, when in attendance at their meetings. This honorarium is over and above their Council indemnity but not in addition to payments made pursuant to Section 7

9. The Deputy Mayor, upon performing the duties of Mayor for a period in excess of one week, shall be compensated as per the Mayor's indemnity for the whole acting period.
10. By-Law #03-129 is hereby repealed.
